

AGREEMENT REGARDING TRANSFER OF FUNDS


Pursuant to section IV.C.1. of the undersigned parties' Postnuptial Agreement dated May 5, 2004, Andrew E. Furer is required to transfer to Eloisa B. Furer the sum of three million dollars (\$3,000,000) on or before May 20, 2004. In order to avoid probate and any estate tax obligation in the event of Eloisa's death prior to completion of the parties' estate planning, the parties agree to transfer the funds to a joint tenancy account at CSFB. The transfer of the funds to the joint tenancy account at CSFB shall not create any rights in the funds that are different than those set forth in the parties' Postnuptial Agreement.
