19 **VERIFIED PETITION FOR JOINT SUMMARY DIVORCE**

20 Pursuant to NRS §125.181 *et. seq.* ELOISA BESADA FURER, Wife, and ANDREW
21 EARL FURER, Husband, jointly as Petitioners hereby respectfully show as follows:

22 1. Petitioner, ELOISA BESADA FURER, is now, and has been for more than six (6)
23 weeks preceding the commencement of this action, a resident of the State of Nevada; that during
24 all of said period, Petitioner has had and still has, the intent to make this state her home,
25 residence, and domicile for an indefinite period of time.

26 2. That Petitioners were married on the 28th day of June, 1981, in Los Angeles
27 County, California and ever since that time have been, and now are, husband and wife.

28 3. That there was one child born the issue of this marriage who is no longer a minor,
that there were no children adopted during the marriage, and that Petitioner, ELOISA BESADA
FURER, to the best of her knowledge, is not now pregnant.

1 4. That the parties have, on or about the 9th day of July, 2004, executed a MARITAL
2 SETTLEMENT AGREEMENT, which is attached hereto as Exhibit "1" and incorporated by
3 reference as though fully set forth herein.

4 5. That there are community property assets and/or obligations of the Petitioners as a
5 result of the marriage of the Petitioners and the above-referenced MARITAL SETTLEMENT
6 AGREEMENT does address these issues in addition to issues of spousal support.

7 6. That Petitioner ELOISA BESADA FURER wishes to continue to be known by
8 her married name; this name is and will continue to be ELOISA BESADA FURER.

9 7. That the parties have agreed to cooperate in executing all deeds, certificates of
10 title, bills of sale, and other evidences of transfer necessary to effectuate the above-referenced
11 MARITAL SETTLEMENT AGREEMENT.

16 9. That the Petitioners waive their rights to written notice of entry of the decree of
17 divorce, to appeal, to request Findings of Fact and Conclusions of Law and to move for a new
18 trial.

19 10. That there exist between the Petitioners conflicts in personalities and dispositions
20 which are so deep as to be irreconcilable and irremediable and which render it impossible for the
21 parties to live together in a normal marital relationship. Accordingly, the parties are
22 incompatible in marriage.

23 11. That the Petitioners desire that the Court enter a decree of divorce.

24 **WHEREFORE**, the Petitioners pray for judgment as follows:

25 1. That the bonds of matrimony now, and heretofore, existing between husband and
26 wife be dissolved; that Petitioners be granted an absolute decree of divorce; and,
27 that each of the Petitioners be restored to the status of a single, unmarried person;
28 and

- 1 2. That the MARITAL SETTLEMENT AGREEMENT dated on or about July 9th,
2 2004, be adopted, ratified, confirmed and approved by this Court in its entirety;
3 and that each of the parties hereto be ordered and directed to fully comply with
4 each, every and all of the terms and provisions thereof; and
5 3. That Petitioner ELOISA BESADA FURER henceforth continue to be known by
6 her married name, the same being ELOISA BESADA FURER; and
7 4. For such other and further relief as this Court may deem proper in the premises.

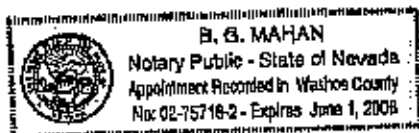

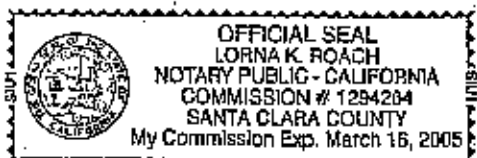
