Dear Sandra:

As I mentioned in prior correspondence, pursuant to the Post Nuptial Agreement we need to set up a joint account to hold the Community Property Washington Mutual Stock and to hold the funds withheld to pay taxes from dividends. Late Friday Mr. Furer was notified that the dividends had been received. Mrs. Furer's share of the dividend on the Community Property stock comes to a gross sum of \$143,000. Mr. Furer believes that a reasonable estimate of the tax burden is 16%. Therefore, he will withhold the sum of \$22,880 from her share, leaving a net sum to her of \$120,120. However, we need to get the proper account set up to hold the funds withheld to pay taxes and to distribute the net sum to her.

I am faxing herewith the documents that Credit Suisse First Boston faxed to me this morning to set up the joint account. Please have Mrs. Furer sign these documents and return them to me. I will then fax or Federal Express them to the Bank so that the account can be set up and the funds distributed properly.

In the meantime, trusting that Mrs. Furer will sign, I need instructions as to how I should deliver the funds. Also, Mr. Furer has claims for damages against Mrs. Furer. We are not waiving these


