Dear Sandra:

As I have mentioned before, Mrs. Furer needs to make arrangements to take Mr. Furer's name off her Bank of America credit card account. The same is true of her cell phone account. She needs to make appropriate arrangements to have both of these accounts in her name alone. Apparently there is the sum of \$1,182.40 due on this credit card. Last month the sum of \$447.49 was withdrawn from his account to pay the debt on this card.

Both companies have advised Mr. Furer that they will cancel the accounts at his request. It is not his intention to try to cause Mrs. Furer hardship. However, if she will not take the simple steps to make sure these accounts in her name alone, he will have no choice but to do so. She can deal with the credit card at the local branch. She can deal with the cell phone by calling 1 800 298-2158.

If she does not accomplish these transfers by Friday, Mr. Furer will have no choice but to advise the companies to cancel the accounts.

Mr. Furer advises me that he gave Mrs. Furer all of the mail he had received which is addressed to her. Will you please make sure Mrs. Furer has a mailing address so that her mail will get to her promptly.
