
Dear Sandra:

As you are aware, consistent with the terms of the Post Nuptial Agreement, the parties are to set up a joint account in which to hold the community property Washington Mutual stock, and the funds withheld to pay the taxes from the recently received dividends. Accordingly, on August 16, 2004, we sent you the documents from Credit Suisse First Boston to set up the joint account, and requested that Mrs. Furer execute the documents and instruct us as to how to deliver to funds to Mrs. Furer.

Since we have not received the executed bank documents, or any instructions as to how to deliver to Mrs. Furer her share of the dividends, we are delivering the funds as follows: Enclosed is check #3002 in the amount of \$120,120.00, payable to Eloisa B. Furer and Sandra Unsworth. As explained in our correspondence to you on August 16, 2004, this amount represents Mrs. Furer's share of the dividend on the community property Washington Mutual stock in the amount of \$143,000, less the reasonable tax burden estimate of 16%. The 16% estimated tax burden results in a deduction of \$22,880 from Mrs. Furer's share of the dividend, for a total payment of \$120,120.

Finally, as explained in our correspondence dated August 16, 2004, Mr. Furer has claims for damages against Mrs. Furer. By delivering these dividends to Mrs. Furer, Mr. Furer is not waiving any such claims. If you have any questions or concerns, please do not hesitate to contact me.
