1. I am a C.P.A. retained by Mr. Furer in connection with this divorce action and make this affidavit of my own personal knowledge.

2. In calculating the interest figures set forth in the accompanying Phase III Reply Brief, I relied upon the actual monthly interest earned on funds in the money market account held in the name of Andrew E. Furer Trust from which the moneys he paid to Mrs. Furer or on her behalf, were drawn. In other words, I calculated the interest he would have actually earned on the funds had they not been withdrawn from the account where they had been deposited.

3. In calculating the interest figures I calculated simple rather than compound interest. In other words, I did not calculate interest on the interest Mr. Furer would have otherwise earned had the funds remained in his money market account.

4. Except as set forth in paragraph 6 below (and one occasion when bills were paid two days apart so I ran interest on both from second date), in calculating the interest figures, I started the interest calculation from the day the expense was incurred or obligation paid.

5. If the Court determines that a different interest rate is more appropriate I can re-calculate the interest payments Mr. Furer claims he is entitled to receive.



6. With respect to the money Mrs. Furer withdrew from Mr. Furer's bank accounts, I am informed and believe that the withdrawals were at various times prior to October 1, 2004, and therefore, for ease of calculation the interest was calculated to run from October 1, 2004.

4. The interest numbers set forth in brief accurately reflect my calculations.


