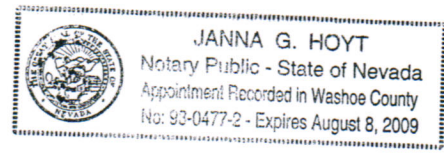
2. Mr. Furer has incurred the following fees and costs associated in making the record of Mrs. Furer's nonappearance are as follows:


