Dear Madam / Sir:

This letter is to advise you that a resident of Clark County, Eloisa Furer, has in the past made death threats concerning her desire to kill Andrew Furer, my client. While these threats have been clearly documented in Court proceedings which exist in Washoe County, I feel it is necessary to provide you with this notice, since Mrs. Furer is a resident of Clark County. Her present address is 9812 Winter Palace, Las Vegas, Nevada.

We expect a final decision from the presiding judge this week in the very acrimonious divorce proceeding. Mrs. Furer has demonstrated her capacity to threaten violence and has made death threats when she receives unfavorable decisions from the sitting judge. Should the upcoming decision be unfavorable to Mrs. Furer, we are very concerned that she may act out her aggression by again attempting to obtain a gun to kill my client, Andrew Furer.


I am not sure what, if any, prophylactic measures can be taken at this juncture. However, since there is an extended Temporary Restraining Order Against Domestic Violence in place that was entered as a result of death threats by Mrs. Furer against Mr. Furer, we feel compelled to put Metro on notice of these proceedings in the event there is a violation of the Domestic Violence Order. Should we receive any indications or evidence that Mrs. Furer is, once again, considering making or executing death threats against Mr. Furer, we will notify your office so that appropriate proceedings can be instituted for Mrs. Furer's violation of the existing Order Against Domestic Violence.
