
Paragraph 9 of the Decree of Divorce entered in this case on February 22, 2008, establishes an expedited procedure to have the Court clerk execute documents that are reasonably necessary to implement the Decree if a party refuses to sign them herself. The relevant portion of the Decree is attached hereto as Exhibit 1.

Pursuant to Paragraph 9 of the Decree, we respectfully request that you direct the Clerk of the Court to execute the attached letter on behalf of Ms. Furer transferring to Mr. Furer assets awarded to him by the Decree. The affected account (Account #219624798 at Credit Suisse) is expressly listed as among the assets that become Mr. Furer's separate property in the MSA. See PNA ¶ IV, E.4, incorporated by reference into the MSA. Relevant portions of the PNA and MSA are attached as Exhibits 2 and 3 hereto.

On March 7, 2008, Ms. Furer, through her attorney Mr. Lueck, was given notice of our request that Ms. Furer execute the attached letter on or before March 13, 2008, more than two days from the present date. See letter to Mr. Lueck, attached as Exhibit 4. Mr. Lueck has not responded to the notice, nor has he indicated any objection thereto. No stay of the judgment in this case has been sought by Ms. Furer, nor has one been granted by this Court.

Accordingly, please direct the Clerk of the Court to Execute the attached letter on behalf of Ms. Furer where indicated and return the executed letter to us as soon as possible.
