Dear Mr. Fitting and Mr. Lueck:

As you know, we have been making every effort to finalize the transfer of the undisputed property pursuant to the Decree of Divorce, including title and registration of Mrs. Furer's three cars, title and registration of Mr. Furer's car, titles to the Manila and Paris condominiums, the Gstaad lease and the foreign bank accounts. Mr. Lueck has recently informed me that Mrs. Furer is now interested in getting these assets transferred to the appropriate party.

When Mrs. Furer failed and refused to sign the documents related to the cars, we obtained a court order pursuant to which the clerk of the court signed on Ms. Furer's behalf. The DMV, however, was not satisfied by the Order. I then wrote the DMV explaining the problems and asking for their advice. I have enclosed a copy of the letter we received from the DMV.



Director Ginny Lewis requested a response to your letter dated May 8, 2008. Below I have outlined the steps to follow for each vehicle to complete the process of transferring title and registration on the vehicles listed. We will also need a certified copy of the court documents submitted with your letter.

For the 2004 Mercedes VIN WDBSK75F94F073426

- The title or designation of the person signing as buyer.
- Enter the buyers address so the title will reflect their address. The title will be mailed c/o Robert Lueck.
- There wasn't a copy of the back of this title, please complete the lien holder area, if there is not a lien please enter 'None'.
- The title fee is \$20.00 and the registration fee is \$5.00.

For the 1998 Mercedes VIN WDBJF82F9WX005425

- The title or designation for the person signing as buyer.
- Person signing as buyer for Eloisa Furer also needs to sign as seller due to the name designation of 'And' listed on the title.
- Enter the buyers address so the title will reflect their address. The title will be mailed c/o Robert Lueck.
- The title fee is \$20.00 and the registration fee is \$5.00.

For the 1988 Mercedes VIN WDBBA48D4JA086525

- The title or designation for the person signing as buyer.
- Enter new lien holder information on the back of the title; if there is not a lien enter 'None'.
- Person signing as buyer for Eloisa Furer also needs to sign as seller due to no name designation listed on the title.
- VIN inspection completed.
- Enter the buyers address so the title will reflect their address. The title will be mailed c/o Robert Lueck.
- The title fee is \$20.00 and the registration fee is \$5.00.
