

ORDER

This Court entered an order on October 29, 2008, in which it directed Ms. Furer to file a response to Mr. Furer's objection no later than Monday, November 10, 2008. This Court admonished Ms. Furer that it would construe her failure to file a response as a confession of error.

Ms. Furer failed to file a response. Additionally, after reviewing the entire record, the points and authorities filed by Mr. Furer, and the Supreme Court's recent decision in Rivero v. Rivero, \_\_\_ Nev. \_\_\_, \_\_\_ P.3d \_\_\_ (October 30, 2008), this Court concludes the master erred as a matter of law.


Mr. Furer shall electronically submit a proposed order to the Department Two Administrative Assistant. The order shall preserve the master's recommended findings and modify the recommended conclusions. The proposed order shall incorporate the points and authorities set forth in the objection. The proposed order shall direct Ms. Furer to surrender herself to the Washoe County Jail on December 10, 2008. Ms. Furer shall

1 serve 10 days, with the remaining 30 days to be suspended. The proposed order shall  
2 require Mr. Furer to effectuate personal service upon Ms. Furer.

3 The hearing scheduled for December 16, 2008, is vacated.


