16 Exhibit "A", pages 34, 36-40. Despite the legal irrelevance of Mr. Furer's current relationship,
17 it appears that Mrs. Furer's main investigative concern has involved Mr. Furer's girlfriend,
18 Julie Blain.² For whatever reason, Mrs. Furer is intensely interested in Ms. Blain's employment
19 situation, her background, and her past relationships. Mrs. Furer then leaves abusive and
20 harassing telephone messages on Mr. Furer's cell phone answering machine regarding the
21 alleged discoveries of her private investigator. *See*, Exhibit "A", pages 34, 36-40.

23 Mrs. Furer's telephone messages also include specific threats to Mr. Furer and his
24 parents regarding her alleged desire to contact the Internal Revenue Service. *See*, Exhibit "A",
25 pages 32-33.² While Mrs. Furer even acknowledges that she is aware that Mr. Furer considers
26 her behavior as harassment towards him and his family, she continues to do so without
