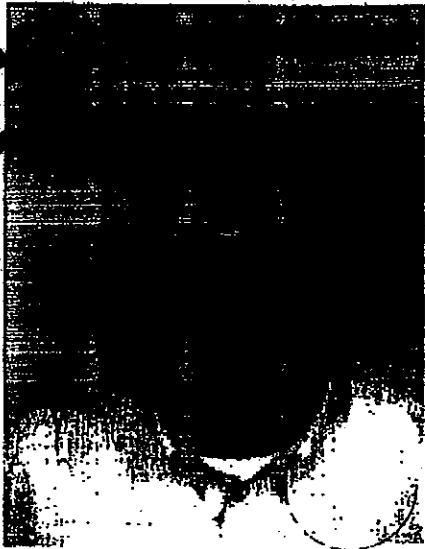

### Narrative

**SUMMARY:** On 06-30-2004 at approximately 1000 and 1100, S-1, FURER, ANDREW was involved in an argument with his wife, V-1, FURER, ELOISA at their home. At one point S-1, ANDREW kicked ELOISA on her right ankle. This caused a bruise to appear on the ankle.

**DETAILS:** On 06-30-2004 at approximately 1525 hours, I was dispatched to the front of the substation on a report of a DOMESTIC DISPUTE occurring there. I was in the driveway and logged on scene at that time. I found S-1 standing near the front doors of the station and V-1 at her car in the lot. As I exited my car, both parties approached and started telling me about the disagreement they were having. I asked them to stop and tell me one at a time what was going on.

At this point, S-1, Andrew started to tell me that they had separated but that he had moved back into the house and that they were not able to work things out and he wanted to gather some clothing and his computer and just leave the house. At this point, V-1, Eloisa came up and told me that her husband had kicked her this morning and that he had done it another time a couple of weeks ago. She showed me a fresh bruise on her right ankle and a scrape type of injury that had scabbing on the surface.



**Narrative**

At this point, I separated the two and had V-1, Eloisa go inside the station to start a written statement. She told me that they were arguing over the divorce settlement and that they had it worked out but that his attorney wanted to change the agreement. At one point in the argument S-1, ANDREW kicked her on her right ankle. At this point Deputy D. Day6 arrived on the scene and I asked him to take some CSI photos of V-1 (See CSI supplemental by D. Day). Deputy Day stayed with V-1, Eloisa while she wrote her statement.

I went back to talk with Andrew and get his side of what happened. He was talking on his cell phone to a person he said was his attorney and at one point tried to hand me the phone. I declined and asked him if he would give me a statement on what happened this morning and why she was claiming that he kicked her. He started telling me that he was on the phone with their banker and she kept interrupting him. I asked why she is saying he kicked her. He said "If something like that happened it was an accident while I was trying to calm her down". At this point I placed him under arrest for Domestic Battery and took him into custody without incident or injury.

I obtained a written statement from Eloisa and asked her if she wanted paramedics to respond to check out her ankle she said no. I provided her with the information for Tahoe Womens Services and the information for obtaining a TPO. I advised that her husband would be transported to the main detention center at Parr Blvd. in Reno and that he would have to be there twelve (12) hours per state law before he could bail out.

She told me that she didn't want this to happen to him and she offered to withdraw charges. I told her that at this point the state was charging him not her.
